<b>How to Avoid Paying Interest on Purchases</b>	Your payment due date is at least 23 days after the close of each billing cycle. We will not charge you any interest on your account if you pay your entire balance by the due date each month.

**How We Will Calculate Your Balance:** We use a method called “average daily balance (excluding new purchases)” for all accounts with billing addresses in MI, MN and MT. We use a method called “average daily balance (including new purchases)” for all accounts with billing addresses in AK, ID, ND, SD, WA, WI, and WY.

**Interest Charges—State Information.** The **APR** we use is based on your state of residence, as determined by your billing address. The **APR** for each state is shown in the table below:
